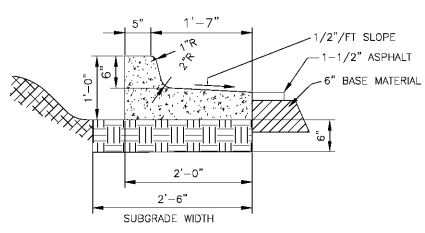
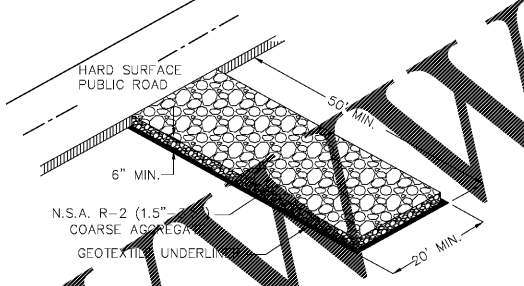


SILT FENCE SHALL BE CLEANED WHEN SEDIMENT REACHES 1/2 THE HEIGHT (14") OF THE FABRIC

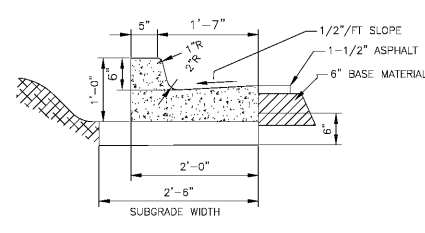
SILT FENCE DETAIL
N.T.S.

ALL SILT FENCE FABRIC SHALL BE CADY INDUSTRIES, STYLE-CSF350 OR AN APPROVED EQUAL, A POLYPROPYLENE FILTER FABRIC

- NOTES:
1. MAINTAIN CONSTRUCTION EXIT SO AS TO PREVENT TRACKING OR FLOW OF MUD ONTO ADJACENT ROADWAY. CLEAN AND/OR TOP DRESS WITH STONE AS NEEDED.
 2. WHERE THE CONSTRUCTION EXIT SLOPES TOWARD THE ADJACENT ROADWAY BY MORE THAN 2%, PROVIDE A 6" HIGH DIVERSION RIDGE WITH 3:1 SIDE SLOPES APPROXIMATELY 15 FEET ALONG THE ROAD.
 3. IF NEEDED, INSTALL A WHEEL WASHING STATION TO KEEP EXISTING ROAD CLEAN AND FREE OF SEDIMENT.
 4. IF A WHEEL WASHING STATION IS REQUIRED, PROVIDE POSITIVE DRAINAGE TO AN APPROVED SEDIMENT CONTROL DEVICE.



1. PLACE EXPANSION JOINTS EVERY 200', AT ALL RADIUS POINTS AND AT EACH TRAP LOCATION.
2. PLACE CONTRACTION JOINTS EVERY 10'.
3. SUBGRADE MATERIAL SHALL BE COMPACTED TO 95% OF THEORETICAL DRY DENSITY BEFORE PLACING CONCRETE.
4. SUBGRADE TO MEET GDOT CONSTRUCTION SPECIFICATIONS.



1. PLACE EXPANSION JOINTS EVERY 200', AT ALL RADIUS POINTS AND AT EACH TRAP LOCATION.
2. PLACE CONTRACTION JOINTS EVERY 10'.
3. SUBGRADE MATERIAL SHALL BE COMPACTED TO 95% OF THEORETICAL DRY DENSITY BEFORE PLACING CONCRETE.
4. SUBGRADE TO MEET GDOT CONSTRUCTION SPECIFICATIONS.

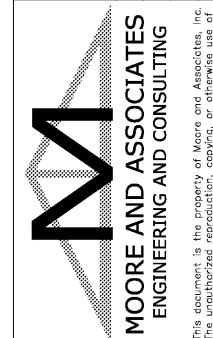

Co	CONSTRUCTION EXIT		Co (LABEL)	A STONE-STABILIZED PAD LOCATED AT ANY POINT WHERE TRAFFIC WILL BE LEAVING A CONSTRUCTION SITE TO A PUBLIC RIGHT-OF-WAY, STREET, ALLEY, SIDEWALK, OR PARKING AREA.
Sd1	SEDIMENT BARRIER		Sd1 (NO SCALE TYPE)	A TEMPORARY STRUCTURE MADE OF SILT FENCE SUPPORTED BY STEEL OR WOOD POSTS, SANDBAGS, STRAW BALES OR OTHER FILTERING.
St	STORM DRAIN OUTLET PROTECTION		St (LABEL)	PAVING AND/OR WRAPPED CHANNEL SECTION PLACED AT LOW POINT OF DRAIN

Bf	CONSTRUCTION EXIT		Bf (LABEL)	AN UNDISTURBED OR PLANTED VEGETATIVE STRIP AROUND A SITE OR BORDERING A STREAM
Ds1	DISTURBED AREA STABILIZATION (WITH MULCHING ONLY)		Ds1	A TEMPORARY COVER OF PLANT RESIDUES APPLIED TO THE SOIL SURFACE FOR A PERIOD OF SIX MONTHS OR LESS WHEN SEEDING IS NOT PRACTICAL.
Ds2	DISTURBED AREA STABILIZATION (WITH TEMPORARY SEEDING)		Ds2	A TEMPORARY VEGETATIVE COVER WITH FAST GROWING SEEDING FOR UP TO A TWELVE MONTH PERIOD OR UNTIL PERMANENT VEGETATION IS ESTABLISHED.
Ds3	DISTURBED AREA STABILIZATION (WITH PERMANENT VEGETATION)		Ds3	A PERMANENT VEGETATIVE COVER USING GRASSES, TREES, SHRUBS OR LEGUMES ON HIGHLY ERODIBLE OR CRITICALLY ERODED LANDS.
