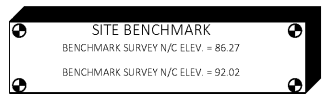

GENERAL PAVING NOTES

- CONTRACTOR SHALL INSTALL EXPANSION JOINTS EVERY 60 FEET AND SAWCUT CONTROL JOINTS EVERY 15 FEET FOR CONCRETE PAVEMENT.
- THE PAVING CONTRACTOR SHALL COORDINATE WITH THE UTILITY AND IRRIGATION CONTRACTORS TO ENSURE THAT ALL SLEEVES HAS BEEN INSTALLED PRIOR TO PLACEMENT OF PERMANENT PAVEMENT.
- ALL PAVING AND EARTHWORK OPERATIONS SHALL CONFORM TO THE RECOMMENDATION OF THE GEOTECHNICAL REPORT.
- REFER TO GEOTECHNICAL REPORT PREPARED BY E.C. MD-ATLANTIC, LLC, ENTITLED "SUBSURFACE EXPLORATION AND GEOGRAPHICAL ENGINEERING ANALYSIS", DATED AUGUST 2, 2017, PROJECT NUMBER 0713871, PROVIDED FOR PAVING AND SUBGRADE PREPARATION REQUIREMENTS.
- ALL DIMENSIONS SHOWN ARE TO THE FACE OF CURB UNLESS OTHERWISE NOTED.
- UNLESS OTHERWISE SHOWN, CALLED OUT OR SPECIFIED HEREON OR WITHIN THE SPECIFICATIONS, ALL CURB AND GUTTER SHALL BE INSTALLED PER DETAIL 70A. PAVEMENT SHALL BE INSTALLED IN ACCORDANCE WITH PAVEMENT SECTION DETAILS OVER THE ENTIRE PARKING LOT AREA AND ALL APPROACH DRIVES.
- CONTRACTOR SHALL SUPPLY AN ALTERNATE BID FOR PLACEMENT OF STANDARD DUTY AND HEAVY DUTY P.C. CONCRETE IN LIEU OF STANDARD DUTY AND HEAVY DUTY ASPHALTIC PAVEMENT.
