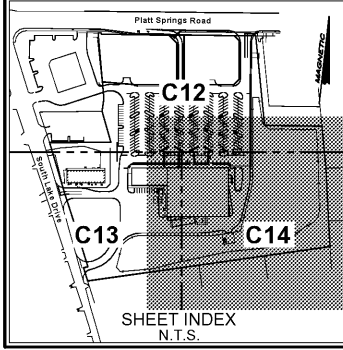

- (W1) 8" TAP AND GATE VALVE ON EXISTING 12" WATER MAIN BY CONTRACTOR UPON APPLICATION AND PAYMENT OF FEES BY THE OWNER TO LEXINGTON COUNTY JOINT MUNICIPAL WATER AND SEWER COMMISSION (LCJMWSC).
- (W2) INSTALL 8" DUCTILE IRON PIPE BY MEANS OF OPEN CUT OF 36" DEPTH IS BEING MILLED OVERLAP AS A PART OF THE RESTRICTION PLAN. SEE PAVEMENT REPAIR DETAIL.
- (W3) FURNISH AND INSTALL NEW 8" DIAMETER DUCTILE IRON PIPE WITH THRUSTR RESTRAINT MEETING LCJMWSC AND NFPA 24 REQUIREMENTS AS APPLICABLE.
- (W4) CONTRACTOR SHALL FURNISH AND INSTALL 8" DIAMETER 22.5' M.J. DI BEND WITH THRUSTR RESTRAINT MEETING LCJMWSC AND NFPA 24 REQUIREMENTS AS APPLICABLE.
- (W5) CONTRACTOR SHALL FURNISH AND INSTALL 8" DIAMETER 22.5' M.J. DI BEND WITH THRUSTR RESTRAINT MEETING LCJMWSC AND NFPA 24 REQUIREMENTS AS APPLICABLE.
- (W6) CONTRACTOR SHALL FURNISH AND INSTALL 8" DIAMETER 22.5' M.J. DI TEE WITH THRUSTR RESTRAINT MEETING LCJMWSC AND NFPA 24 REQUIREMENTS AS APPLICABLE.
- (W7) CONTRACTOR SHALL FURNISH AND INSTALL 8" DIAMETER 22.5' M.J. DI TEE WITH THRUSTR RESTRAINT MEETING LCJMWSC AND NFPA 24 REQUIREMENTS AS APPLICABLE.
- (W8) FURNISH AND INSTALL 8" GATE VALVE WITH BOX.
- (W9) CONTRACTOR SHALL FURNISH AND INSTALL NEW FIRE HYDRANT ASSEMBLY ON 6" CLASS-51 ASPHALT COATED, CEMENT LINED D.I. LEAD. ASSEMBLY INCLUDES HYDRANT VALVE INSTALLATION.
- (W10) FURNISH AND INSTALL NEW 8" DIAMETER DUCTILE IRON PIPE PRIVATE FIRE MAIN, MAINTAIN 3' OF COVER AT A MINIMUM.
- (W11) WATER SERVICE ENTERS THE BUILDING AT THE SPRINKLER RISER ROOM. SEE PLUMBING PLANS FOR EXACT LOCATION OF THE SPRINKLER RISER ROOM AND BUILDING MOUNTED FDC.
- (W12) 8" C-900 FIRE LINE TO REMOVE FIRE DEPARTMENT CONNECTION. VERIFY LOCATION WITH PLUMBING PLAN.
- (W13) FURNISH AND INSTALL 8" JAMES 3000SS DOUBLE DETECTOR CHECK VALVE IN EXTERIOR BELOW-GRADE VAULT WITH ACCESS HATCH.
- (W14) 2" WATER SERVICE WITH 2" METER AND BACKFLOW PREVENTION. CONTRACTOR SHALL INSTALL SERVICE LINE AND METER BOX. METER TO BE SET BY LCJMWSC AFTER APPLICATION AND PAYMENT OF ALL FEES BY OWNER. COORDINATE WITH LCJMWSC. CONTRACTOR SHALL EXTEND SERVICE LINES TO WITHIN 5' OF BUILDING. SERVICES TO HAVE 2' MIN. SEPARATION. COORDINATE WITH PLUMBING DRAWING FOR LOCATION(S) WHERE WATER SERVICE(S) ENTER THE BUILDING.
- (W15) INTENTIONALLY OMITTED.
- (W16) 2-1/2" WATER SERVICE LINE WITH 2" METER AND BACKFLOW PREVENTION. CONTRACTOR SHALL INSTALL SERVICE LINE AND METER BOX. METER TO BE SET BY LCJMWSC AFTER APPLICATION AND PAYMENT OF ALL FEES BY OWNER. COORDINATE WITH LCJMWSC. CONTRACTOR SHALL EXTEND SERVICE LINES TO WITHIN 5' OF BUILDING. COORDINATE WITH PLUMBING DRAWING FOR LOCATION(S) WHERE WATER SERVICE(S) ENTER THE BUILDING.
- (W17) 3/4" WATER SERVICE WITH 3/4" METER TO FREEZE PROOF HOSE BIB FOR LIFT STATION. CONTRACTOR SHALL INSTALL SERVICE LINE AND METER BOX. METER TO BE SET BY LCJMWSC AFTER APPLICATION AND PAYMENT OF ALL FEES BY OWNER. COORDINATE WITH LCJMWSC. CONTRACTOR SHALL EXTEND SERVICE LINES TO HOSE BIB. SEE PUMP STATION DETAILS FOR MORE INFORMATION.
- (W18) WATER MAIN CROSSES STORM DRAINAGE IN THIS AREA - SEE PROFILES FOR MORE INFORMATION.
- (W19) WATER MAIN CROSSES SANITARY SEWER IN THIS AREA - SEE PROFILES FOR MORE INFORMATION.
- (W20) PROPOSED LEXINGTON COUNTY JOINT MUNICIPAL WATER AND SEWER COMMISSION (LCJMWSC) EASEMENT. SEE PLAN FOR WIDTH.
- (W21) 2" IRRIGATION WATER SERVICE LINE WITH 2" METER AND BACKFLOW PREVENTION. CONTRACTOR SHALL INSTALL SERVICE LINE, METER BOX. METER TO BE SET BY LCJMWSC AFTER APPLICATION AND PAYMENT OF ALL FEES BY OWNER. SEE LANDSCAPE PLAN FOR CONTINUATION OF IRRIGATION LINES.
- (W22) 1-1/2" GAS LINE. COORDINATE WITH UTILITY PROVIDER FOR CONNECTION.
- (W23) FURNISH AND INSTALL NEW 8" C900 WATER MAIN. MAINTAIN 3' OF COVER AT A MINIMUM. PVC SHALL BE USED IN ALL NON-PAVEMENT AREAS.
- (W24) CONTRACTOR SHALL FURNISH AND INSTALL 8" DIAMETER 11.25' M.J. DI BEND WITH THRUSTR RESTRAINT MEETING LCJMWSC AND NFPA 24 REQUIREMENTS AS APPLICABLE.

CONTRACTOR NOTES:

- 1) THE OWNER SHALL PAY ALL LEXINGTON COUNTY JOINT MUNICIPAL WATER AND SEWER COMMISSION (LCJMWSC) WATER FEES FOR THE PROJECT.
- 2) CONTRACTOR SHALL FURNISH AND INSTALL METER BOXES. OWNER SHALL PAY ALL METER FEES.
- 3) ONLY A LCJMWSC-APPROVED CONTRACTOR CAN SET METERS AND MAKE TAPS. THE APPROVED CONTRACTOR LIST CAN BE OBTAINED FROM LCJMWSC. THIS CONTRACTOR SHALL BE A SUBCONTRACTOR.
- 4) OWNER SHALL COORDINATE AND PAY ALL TAP FEES.
- 5) CONTRACTOR TO COORDINATE WITH LANDSCAPE PLANS FOR LOCATION OF IRRIGATION LINES AND SLEEVES.
- 6) CONTRACTOR TO COORDINATE WITH ARCHITECTURAL/PLUMBING DRAWING FOR FDC LOCATION. INSURE FDC'S ARE LOCATED NO FURTHER THAN 100' FROM A FIRE HYDRANT.

NOTE TO OWNER AND CONTRACTOR:

WATER:
AT COMPLETION OF THE WATER CONSTRUCTION THE PROJECT MUST BE GRANTED APPROVAL FROM LEXINGTON COUNTY JOINT MUNICIPAL WATER AND SEWER COMMISSION (LCJMWSC) AND RECEIVE AN OPERATIONAL PERMIT FROM SCDHEC. IT IS IMPERATIVE THAT COX AND DINKINS, INC. RECEIVE CERTIFIED RECORD DATA FROM THE CONTRACTOR'S REGISTERED LAND SURVEYOR IN A TIMELY FASHION TO ALLOW A RECORD WATER PLAN TO BE GENERATED AND SUBMITTED THROUGH LCJMWSC. THE CONTRACTOR'S SURVEYOR SHALL PROVIDE SIGNED HARD COPIES OF THE RECORD DRAWING AND DIGITAL INFORMATION TO THE ENGINEER. THE SURVEYOR SHALL PROVIDE LOCATIONS OF ALL APPURTENANT ITEMS INCLUDING BUT NOT LIMITED TO BENDS, VALVES, TAP LOCATIONS, HYDRANTS, REDUCERS, ETC.

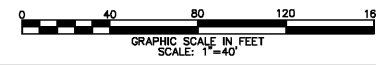
EASEMENT DOCUMENTATION WILL BE PREPARED BY DEVELOPERS ATTORNEY BASED UPON THE RECORD DRAWING. LCJMWSC, WITH HELP FROM THE CONTRACTOR, WILL CONDUCT VARIOUS TESTS ON THE WATER SYSTEM. UPON RECEIPT OF LCJMWSC APPROVAL LETTER COX AND DINKINS, INC WILL PREPARE A PACKAGE FOR SCDHEC'S OPERATIONAL PERMIT REVIEW.
