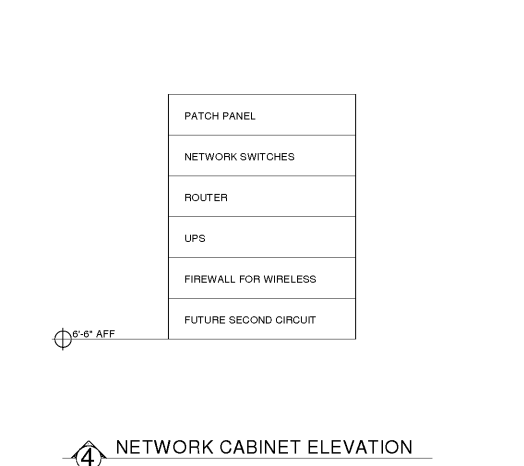

- # EAS ELEVATION NOTES:
- GO TO INTERCONNECT BETWEEN POWER PACK AND SENSORMATIC EAS DEVICES LOCATED AT STOREFRONT ENTRY. CONDUIT TO BE HARD CONNECTED INTO A KNOCKOUT ON CAP BOARD ENCLOSURE. DO NOT SPLICE ANTENNA CABLES. ALL CONDUIT TO BE CONCEALED IN BULKHEAD.
 - GO TO PROVIDE DUPLEX RECEPTACLE BOX LOCATED ADJACENT TO SENSORMATIC EQUIPMENT. ELECTRICAL REQUIREMENTS ARE 120VAC, THREE WIRE, 24 HOUR CIRCUIT WITH LESS THAN 0.5VAC BETWEEN NEUTRAL AND GROUND.
 - AUDIBLE ALARM SPEAKER BY TYCO.
 - POWER PACK UNIT LOCATED ABOVE DOOR, ONE POWER PACK UNIT REQUIRED FOR EACH 10 FEET (OR PORTION THEREOF) OF STOREFRONT OPENING. WHERE THREE POWER PACKS ARE REQUIRED, THE THIRD SHOULD BE LOCATED ON THE SIDE WITH THE LARGER COLUMN. ALL DEVICES AND WORK PROVIDED BY TYCO.
 - MOUNT THE CAP BOARD ENCLOSURE AS CLOSE AS POSSIBLE TO POWER PACK. 7'-0" MAXIMUM DISTANCE FROM POWER PACK TO ENCLOSURE. WORK PROVIDED BY TYCO.
- FOR TECHNICAL QUESTIONS REGARDING INSTALLATION, CALL: TYCO.
- CONTRACTOR SHALL VERIFY AN UNOBSTRUCTED MINIMUM FREE AREA OF 3 FEET VERTICALLY AND 3 FEET WIDE IN EVERY DIRECTION ABOVE THE ACCESS PANEL TO ALLOW FOR INSTALLATION OF THE SENSORMATIC POWER PACK AND ENCLOSURE BOXES. IF FREE AREA CANNOT BE OBTAINED IN THIS LOCATION, IMMEDIATELY CONTACT THE NORTH FACE PROJECT MANAGER FOR FURTHER INSTALLATION INSTRUCTIONS.
