#### General Notes

2. Dimensions are for design intent only.

The owner understands that adjustments to the final locations of equipment and/or furniture placement may be required at the owner's expense due to discrepancies based on actual job site dimensions and conditions.
4. Refer to architectural drawings for complete and accurate dimensions of building structure.

6. These documents may not be copied, reproduced, used, or implemented in any way, without the consent of Seating Concepts.
7. Seating Concepts is not responsible for deviations, changes, additions, or deletions not reviewed and approved in advance by Seating Concepts.

#### Construction

1. The GC shall verify all dimensions and conditions on the job site and notify Seating Concepts of all discrepancies prior to starting work.
2. GC is to review Seating Concepts plans against the architectural drawing set they are using on site. GC shall notify Seating Concepts immediately if they notice discrepancies.
3. Dimensions marked GC to Verify must be verified and the measurements recorded to Seating Concepts. Failure to communicate verified dimensions to Seating Concepts could result in a delay of decor fabrication and possible delay of shipment.
4. GC to locate thermostats and sensors and move accordingly so they do not interfere with decor.

#### Finish Specification & Ordering of Materials

1. GC to order by complete specification, including series, item number and color. Any discrepancies should be communicated to Seating Concepts immediately.
2. Changes to finishes as requested by owner after materials are ordered may result in owner assuming restocking fees or other additional costs associated with a re-selection.

#### Ceiling

1. GC must coordinate all existing HVAC and lighting with interior decor.

#### Electrical

1. All electrical outlets are located 18" A.F.F. unless otherwise noted.
2. All power and data to come from ceiling unless noted otherwise.
3. All electrical fixtures, wiring, and installation to be UL approved.
4. Pendants are to be centered over table top once final installation of seating is complete.

#### Installation

1. GC is to inspect Seating Concepts product upon delivery. Notice of damage must be given within 24 hours of delivery. Any damage noted after this time period will become the responsibility of the GC and will be repaired or replaced at the GC's expense.
2. GC is responsible to protect product during and after installation. Seating Concepts will not be responsible for product replacement due to misuse by others during and/or after installation.
3. GC to refer to installation pages included in the installation instructions packet sent with the decor.
4. GC is responsible to insure appropriate installation of metalwork as required for table tops designated as ADA
