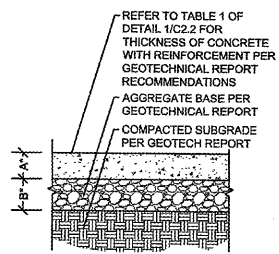

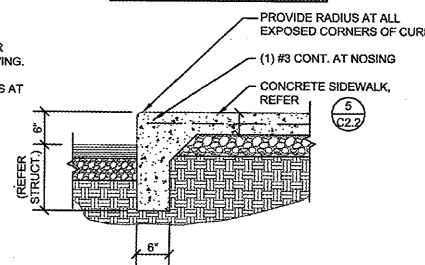

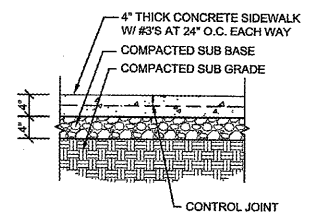
**3 CONCRETE CURB SECTION**

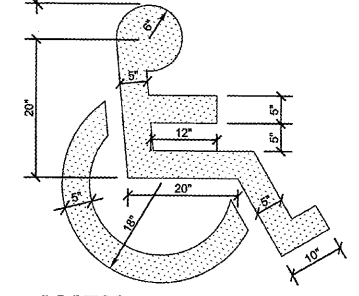
**4 CONCRETE SIDEWALK CURB SECTION**

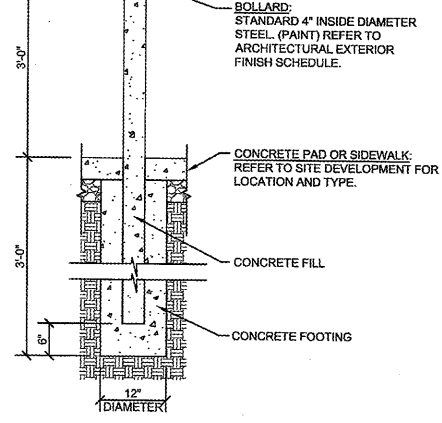

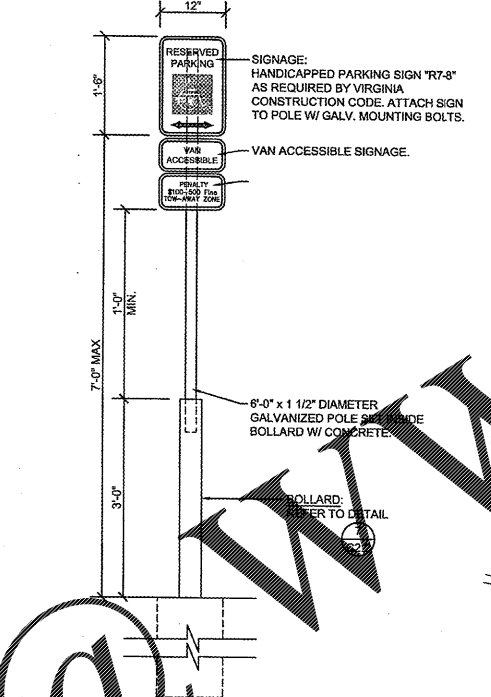

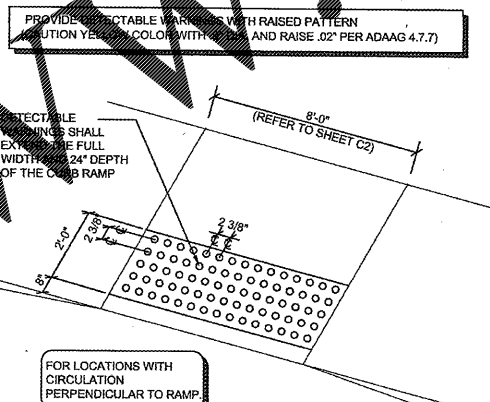
**6 ACCESSIBLE PARKING PAVEMENT STRIPPING DETAIL**

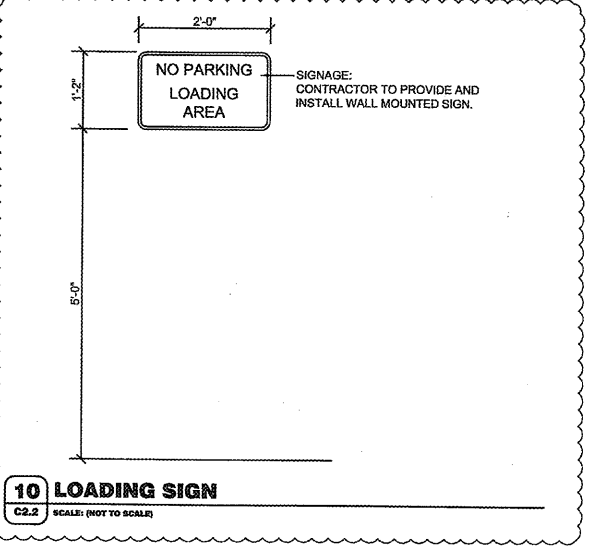
**7 STEEL BOLLARD SECTION**

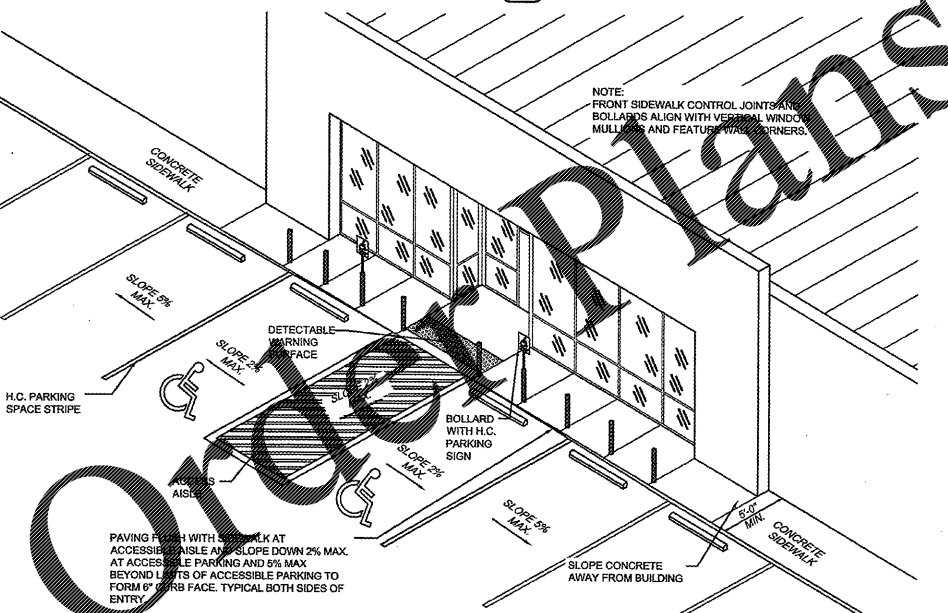
**8 HANDICAP PARKING SIGN DETAIL**
