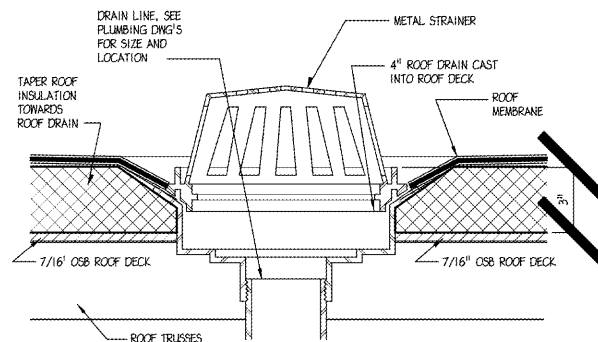
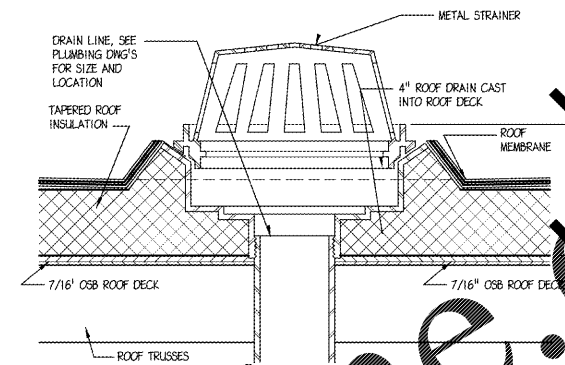

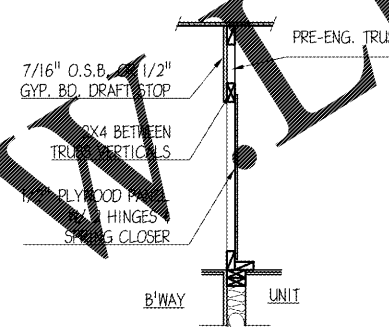

A4.5 SCALE N.T.S.

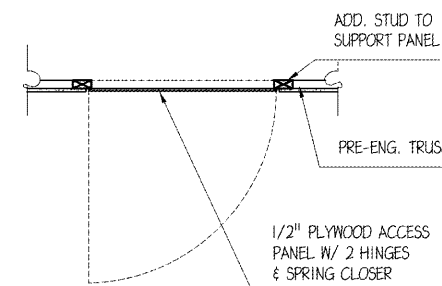
