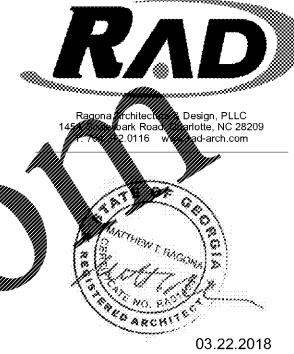


GENERAL NOTES

- THE CONSTRUCTION GENERAL CONTRACTOR IS RESPONSIBLE FOR ALL COORDINATION BETWEEN SUBCONTRACTORS BASED ON ENTIRE SET OF DOCUMENTS. NO EXTRA COMPENSATION WILL BE GIVEN TO A BIDDER OR SUPPLIER WHO HAS BID FROM AN INCOMPLETE SET OF CONSTRUCTION DOCUMENTS. IN CASE OF INCONSISTENCIES OR DISCREPANCIES BETWEEN DRAWING, THE MOST STRINGENT NOTE OR CONDITION SHALL APPLY AND THE CONTRACTOR SHALL NOTIFY PROJECT ARCHITECT IMMEDIATELY OF SUCH DISCREPANCIES.
- ALL CONSTRUCTION SHALL CONFORM WITH ALL LOCAL CURRENT BUILDING CODE(S), WITH AMENDMENTS BY THE GOVERNING ENFORCEMENT BODIES (HEREINAFTER REFERRED TO AS THE CODE), ALL APPLICABLE ORDINANCES AND REGULATIONS, THE SPECIFICATIONS AND THE DRAWINGS.
- PROVIDE ALL NECESSARY BACKING AND FRAMING FOR WALL-MOUNTED ITEMS, LIGHT FIXTURES, INTERIOR AND EXTERIOR SIGNAGE AND ALL OTHER ITEMS REQUIRE SAME.
- THE CONSTRUCTION GENERAL CONTRACTOR IS RESPONSIBLE FOR MAINTAINING A CURRENT SET OF CONSTRUCTION DRAWINGS ON SITE DURING CONSTRUCTION. THE GC SHALL INDICATED ON THESE PLANS ALL APPROVED CHANGES TO THIS WORK. THIS SET SHALL BE TURNED OVER TO PROJECT ARCHITECT WHEN THE PROJECT IS COMPLETE. REFER TO BID DOCUMENTS.
- IF ANY ERRORS, DISCREPANCIES OR OMISSIONS APPEAR ON THESE DRAWINGS, SPECIFICATIONS OR OTHER CONTRACT DOCUMENTS, THE CONTRACTOR SHALL NOTIFY PROJECT ARCHITECT IMMEDIATELY. REFER TO BID DOCUMENTS.
- NO MATERIAL ASSEMBLY OR SYSTEM SUBSTITUTIONS WILL BE ALLOWED UNLESS SUBMITTED IN WRITING TO KRYSSTAL FOR APPROVAL. NOTIFICATION MUST BE SUBMITTED WITH IN 10 WORKING DAYS OF CONTRACT AWARD. REFER TO BID DOCUMENTS.
- THE CONSTRUCTION GENERAL CONTRACTOR IS REQUIRED TO PROVIDE A LIST OF ALL SUBCONTRACTORS TO BE USED AND SHALL SUBMIT THAT LIST TO KRYSSTAL WITHIN 10 WORKING DAYS OF CONTRACT AWARD. REFER TO BID DOCUMENTS.
- THE CONSTRUCTION GENERAL CONTRACTOR IS RESPONSIBLE FOR COORDINATING ALL SHIPMENTS OF OWNER SUPPLIED MATERIALS. THIS INCLUDES VERIFYING PACKING LISTS AGAINST ORDER FORMS AND BILLS OF LADING. IF THIS IS NOT DONE, THE CONTRACTOR WILL BEAR THE COST OF ANY EXPEDITED FREIGHT CHARGES TO MEET THE CONSTRUCTION SCHEDULE. THE CONTRACTOR IS RESPONSIBLE FOR FILING DAMAGE REPORTS AND MUST MAINTAIN PACKING MATERIALS FOR SHIPMENT OF DAMAGED ITEMS.
- THE CONSTRUCTION GENERAL CONTRACTOR SHALL KEEP ALL HANDBOOKS AND PAPERWORK INCLUDING ALL PACKING SLIPS AND BILLS OF LADING IN A MARKED ENVELOPE. THIS ENVELOPE IS TO BE TURNED OVER TO OWNER. REFER TO BID DOCUMENTS.
- THE CONSTRUCTION GENERAL CONTRACTOR SHALL DELIVER A COPY OF THE CERTIFICATE OF OCCUPANCY, LIEN WAIVER, WARRANTIES, GUARANTEES AND EQUIPMENT OPERATION MANUALS. REFER TO BID DOCUMENTS.
- THE CONSTRUCTION GENERAL CONTRACTOR SHALL BE RESPONSIBLE FOR THE CLEANUP OF ALL TRADES. UPON COMPLETION OF CONSTRUCTION, IT WILL BE THE RESPONSIBILITY OF THE GENERAL CONTRACTOR TO CLEAN ALL FINISH SURFACES AS PER MANUFACTURER'S INSTRUCTIONS AND TO EMPLOY THE SERVICES OF A PROFESSIONAL CLEANING COMPANY IN ORDER TO ASSURE AN ABSOLUTELY CLEAN SPACE. REFER TO BID DOCUMENTS.
- THE DRAWINGS ARE NOT TO BE SCALED.
- THE DRAWINGS ARE NOT TO BE ALTERED IN ANY WAY WITHOUT WRITTEN AUTHORIZATION FROM KRYSSTAL.
- COORDINATE ALL ACTIVITIES WITH MANAGEMENT PRIOR TO START OF CONSTRUCTION. INTERRUPTION OF SERVICES TO THE BUILDING SHALL NOT BE ALLOWED. IF REQUIRED, COORDINATE SUCH INTERRUPTIONS WITH MANAGEMENT. EXISTING SERVICES WHICH ARE IN ANY WAY AFFECTED BY THE PERFORMANCES OF THIS WORK SHALL BE PROTECTED AND MAINTAINED, INCLUDING UTILITY SERVICES FOR THE BUILDING THAT ORIGINATE IN OR THROUGH THE SPACE.
- CONSTRUCTION GENERAL CONTRACTOR SHALL BE RESPONSIBLE FOR COORDINATING ALL THEIR WORK AND THE WORK OF THEIR SUBCONTRACTORS WITH STRUCTURE AND BUILDING ELEMENTS. CONSTRUCTION GENERAL CONTRACTOR SHALL IMMEDIATELY NOTIFY PROJECT ARCHITECT OF ANY DISCREPANCIES BETWEEN DRAWINGS AND BUILDING.
- CONSTRUCTION GENERAL CONTRACTOR TO PROVIDE FIRE EXTINGUISHERS AS REQUIRED. VERIFY QUANTITY AND LOCATION WITH LOCAL OFFICIALS AND COORDINATE LOCATION OF SAME WITH ARCHITECT. REFER TO BID DOCUMENTS.
- THE GENERAL CONTRACTOR IS RESPONSIBLE TO ACQUIRE AS-BUILT DRAWINGS FROM ALL SUBCONTRACTORS UPON COMPLETION OF THE PROJECT AND TO SUBMIT TO PROJECT ARCHITECT. REFER TO BID DOCUMENTS.
- DETAILS ARE INTENDED TO SHOW METHOD AND NUMBER OF ACCOMPLISHING WORK. MINOR MODIFICATIONS MAY BE MADE TO FIT THE DIMENSIONS OR CONDITIONS AND SHALL BE INCLUDED AS PART OF THE WORK.
- PENETRATIONS OF PLYWOOD THROUGH FLOORS SHALL BE SEALED WITH NON-HARDENING SEALANT OR GASKETING.
- POSSIBLE SUPPRESSION AND CONTROL SYSTEMS SHALL HAVE SEPARATE SUBMITTALS AND PERMIT.
