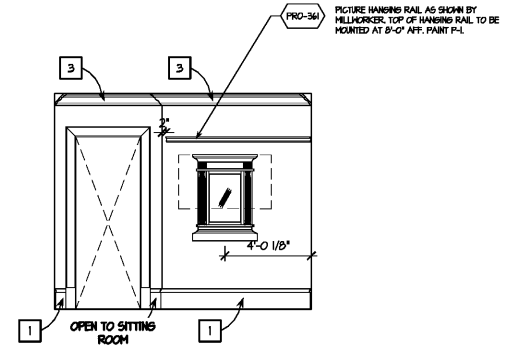
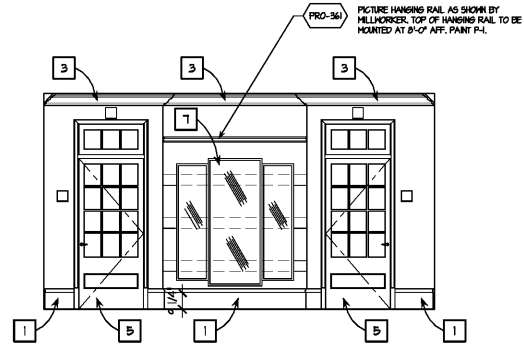


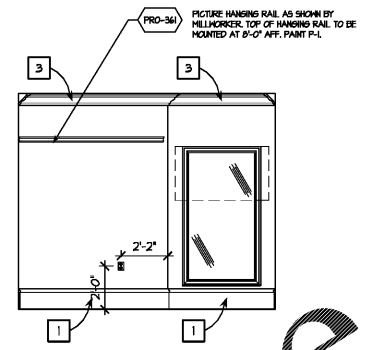
**4 NORTH FITTING ROOM CORRIDOR ELEVATION**

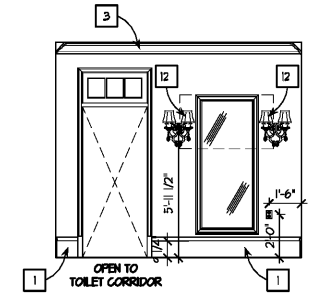
**3 EAST FITTING ROOM CORRIDOR ELEVATION**

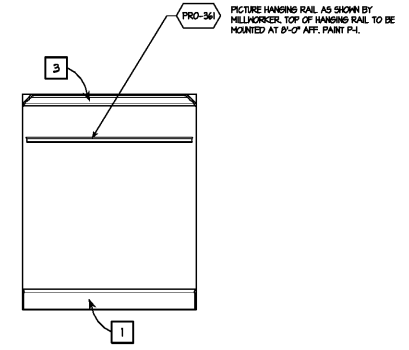
**2 SOUTH FITTING ROOM CORRIDOR ELEVATION**

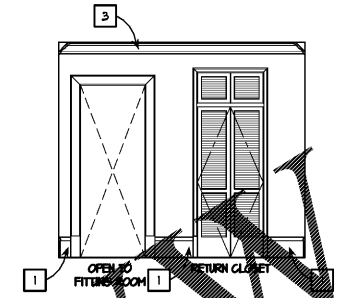

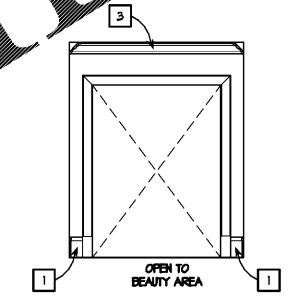

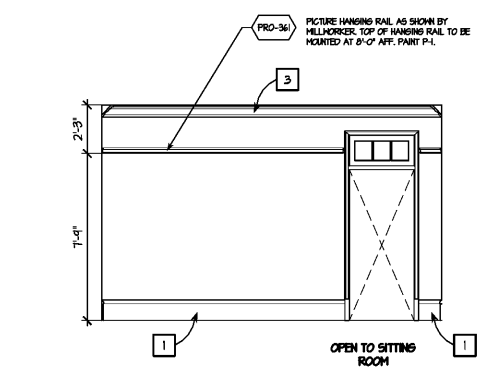

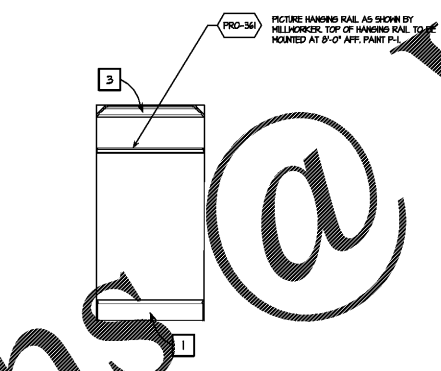

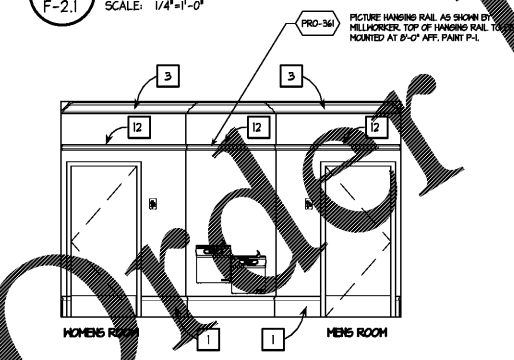

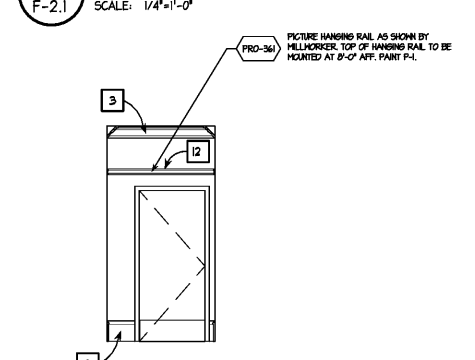

- 2 CROWN MOLDING DETAIL (W/ FRIEZE BD) ON SALES AREA AT CEILING LINE PROVIDED AND INSTALLED BY THE TENANTS FIXTURE CONTRACTOR.
- 3 CROWN MOLDING DETAIL (W/ FRIEZE BD) IN SERVICE CORRIDOR, TOILET ROOMS, AND FITTING ROOMS AT CEILING LINE PROVIDED AND INSTALLED BY TENANTS FIXTURE CONTRACTOR.
- 4 COSMETIC COUNTERTOPS WITH INTERNAL REQUIREMENTS FOR ELECTRICAL OUTLETS FOR VERTICAL DIVIDER LIGHTING, CORNICE LIGHTING AND AN OUTLET FOR A VIDEO MONITOR. CENTER CABINET HAS A SINK, WALL MOUNTED FAUCET. PRIOR TO WALL CONSTRUCTION MILLHORK CONTRACTOR SUPPLIES GENERAL CONTRACTOR WITH FLOOR TEMPLATES FOR CABINET PLACEMENT TO INSURE ANGLED WALL PROPER PLACEMENT AND PLUMBING OUTLETS; COORDINATE WITH ELECTRICAL AND PLUMBING SHEETS.

- 7 FITTING ROOM 3 WAY MIRROR. CENTERED ON WALL. VERIFY BLOCKING REQUIREMENTS WITH SHOP DRAWINGS.
- 8 DECORATIVE MILLHORK MIRROR WITH TRIM AND ADJACENT SHUTTERS OVER BACKRAP PROVIDED BY TENANTS FIXTURE CONTRACTOR (SLJ) AND INSTALLED BY MILLHORK INSTALLER.
- 9 2x2 TRY-2 BASE AT STOREFRONT. INSTALLED BY GENERAL CONTRACTOR. SEE DECOR PLAN FOR FINISH SPEC.
- 10 SURFACE APPLIED 4" H VINYL LETTERING WITH TENANT PHRASE: "MY TIME MY PLACE. MY SELE." ON BEAUTY AREA SOFFIT. SEE DECOR SPEC 0F-2 FOR VINYL COLOR.
