- WHERE PROPOSED UTILITIES CROSS UNDER STORM PIPING, CONTRACTOR SHALL REMOVE AND REUSE EXISTING PIPING AS NECESSARY. WHERE EXISTING PIPING CANNOT BE REUSED CONTRACTOR SHALL FURNISH NEW RCP AS REQUIRED AND QUANTITIES SHALL BE ADDED TO CONTRACT VIA CHANGE ORDER UTILIZING UNIT PRICES.
 - CONTRACTOR SHALL CONFIRM ALL UTILITY LOCATIONS AND DEPTHS PRIOR TO COMMENCING CONSTRUCTION.
 - ANY ELECTRICAL UTILITIES DAMAGED DURING CONSTRUCTION SHALL BE REPAIRED BY THE UNIVERSITY AT THE CONTRACTOR'S EXPENSE. THE UNIVERSITY MAY ELECT TO REPAIR ANY UTILITIES DAMAGED BY THE CONTRACTOR DURING CONSTRUCTION AT THE CONTRACTOR'S EXPENSE.
 - WHERE SHOWN ON THE PLANS, DISTURBANCE LIMITS IN VEGETATED AREAS ARE FIRM. WHERE NOT SHOWN ON THE PLANS, THE ALLOWABLE DISTURBANCE LIMITS IN VEGETATED AREAS IS 8' EITHER SIDE OF PROPOSED UTILITIES. ANY DEVIATION FROM THE ALLOWABLE DISTURBANCE LIMITS SHALL RESULT IN WITHHELD RETAINAGE TO COVER THE UNIVERSITY'S COST TO RESTORE THESE AREAS.
 - WHERE SHOWN ON THE PLANS, DISTURBANCE LIMITS IN HARDSCAPED AREAS ARE FIRM. WHERE NOT SHOWN ON THE PLANS, THE ALLOWABLE DISTURBANCE LIMITS IN HARDSCAPED AREAS IS 4' EITHER SIDE OF PROPOSED UTILITIES. ANY DEVIATION FROM THE ALLOWABLE DISTURBANCE LIMITS SHALL BE REPAIRED BY THE CONTRACTOR AT NO ADDITIONAL COST TO THE UNIVERSITY.
 - LIGHT POLES INDICATED TO BE REMOVED BY THE CONTRACTOR IN THIS PROJECT SHALL BE PROTECTED DURING REMOVAL AND PROVIDED TO THE OWNER.
