- C-1 ALL WORK TO BE IN AREA OF CONTRACT ONLY. ALL APPLICABLE AREAS TO BE PROTECTED DURING ALL PHASES OF CONSTRUCTION.
- C-2 PATCH AND REPAIR FLOOR SLAB DUE TO REMOVAL OF EXISTING CENTER COLUMN/STAIR CORNER AND ASSOCIATED SUPPORTS, FORMWORK, ETC. PATCH SLAB AT REINFORCING FOR NEW POWER/GRAB BAR ARCHITECT.
- C-3 PROVIDE NEW FINISHED GYP OPENING, REFER TO ELEVATION.
- C-4 PATCH WALL AND REPAIR EXISTING WALL FINISHES AS REQUIRED TO MATCH ADJACENT EXISTING TO FINISH.
- C-5 PATCH AND REPAIR WALL CORNER AS REQUIRED DUE TO DEMOLITION, PROVIDE FINISH AS REQUIRED.
- C-6 WALL THICKNESS TO MATCH EXISTING, GO TO VERIFY EXISTING CONSTRUCTION.
- C-7 PROTECT EXISTING BOUNDARY EQUIPMENT DURING CONSTRUCTION, COORDINATE WITH OWNER PRIOR TO COMMENCING WORK. OWNER TO RELocate EXISTING WALL, REFER TO GC TO COORDINATE PATCH AND REPAIR OF APPROACH WITH ARCHITECT.
- C-8 PROVIDE EXISTING WITH WALL BE REQUIRED TO SUPPORT MILLWORK ARCHITECT GAMES TO BE BY OWNER, COORDINATE ARCHITECT, AND ALL OTHERS WITH OWNER, COORDINATE FINISHES AND DATA WITH OWNER, POWER AND DATA PLAN, AND CONSULTS, PRIOR TO INSTALL.
- C-9 PROVIDE EXISTING WITH WALL BE REQUIRED TO SUPPORT MILLWORK ARCHITECT GAMES TO BE BY OWNER, COORDINATE ARCHITECT, AND ALL OTHERS WITH OWNER, COORDINATE FINISHES AND DATA WITH OWNER, POWER AND DATA PLAN, AND CONSULTS, PRIOR TO INSTALL.
- C-10 PROVIDE WATERPROOFING MEMBRANE FOR NEW WALL MOUNTED TYS COORDINATE WITH ENGINEERING CONSULTANTS.
- C-11 PROVIDE WATERPROOFING MEMBRANE FOR FINISH AS REQUIRED DUE TO DEMOLITION OF NEW FLOORING/SLAB AND FLOOR FINISHES.
- C-12 SEE KITCHEN DRAWINGS FOR EQUIPMENT LAYOUT.
- C-13 PATCH ANY HOLE IN EXISTING REPAIR WALL TILES AND PROVIDE FINISH AS REQUIRED TO MATCH ADJACENT EXISTING TO FINISH.

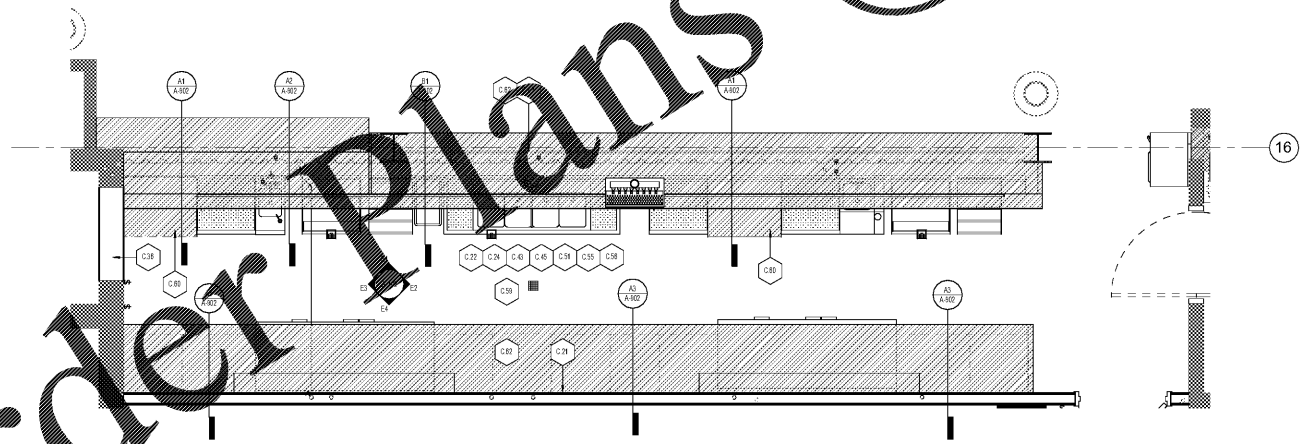

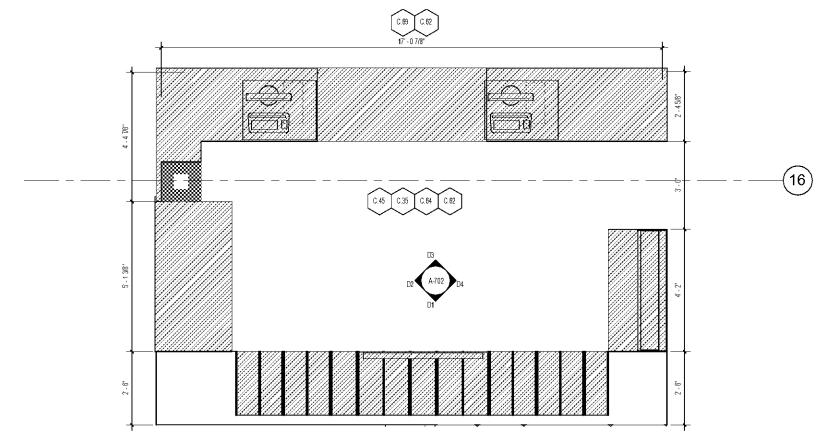
