

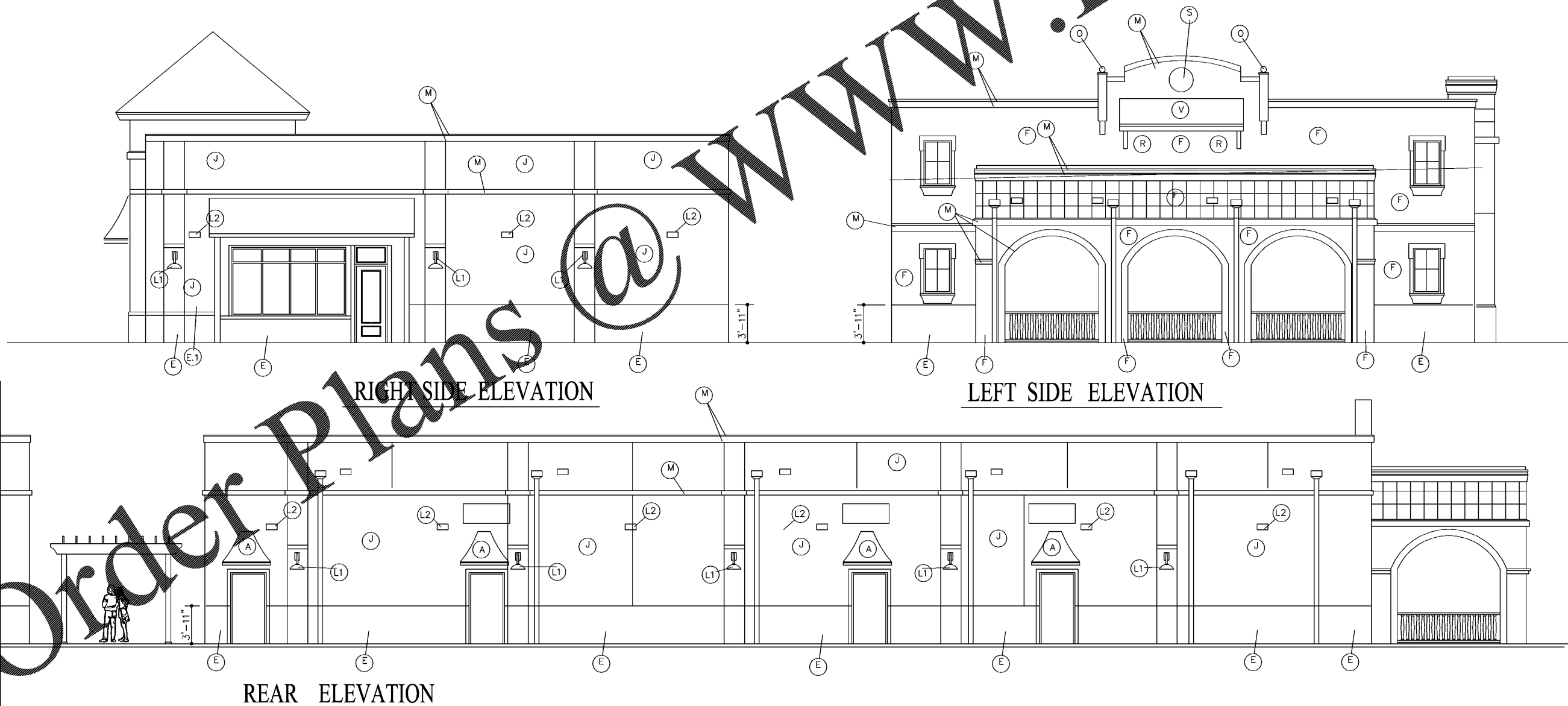

ALL EXTERIOR LIGHT FIXTURES - BRONZE  
NEW BRICK AND LIMESTONE SAMPLES - MIN SIZE OF 8" X 8" BOARDS  
ALL SPECTIS ITEMS REQUIRE A FINAL PAINT COAT IN THE FIELD

CONTRACTOR TO ONLY USE CERTIFIED SUB CONTRACTORS EXPERIENCED IN INSTALLING THE DRYVIT OUTSULATION SYSTEM
