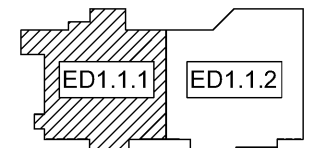


**GENERAL NOTES**

1. SEE SHEET E.01 FOR LEGEND, ABBREVIATIONS, AND PROJECT GENERAL NOTES.
2. ALL EXISTING LIGHT FIXTURES ARE TO DEMOLISHED UNLESS OTHERWISE NOTED.
3. FOR FIXTURES TO BE REMOVED, REMOVE EXPOSED CONDUIT AND WIRING BACK TO THE SOURCE OR TO THE NEXT UPSTREAM DEVICE, FIXTURE, OR PANELBOARD. REMOVE UNUSED WIRING IN CONDUITS CONCEALED ABOVE CEILING OR IN WALLS AND ABANDON THE CONDUITS IN PLACE. MODIFY EXISTING CIRCUITS AS REQUIRED TO MAINTAIN CIRCUIT CONTINUITY TO EXISTING FIXTURES AND DEVICES THAT ARE TO REMAIN DURING DEMOLITION AND AFTER. ALL EXISTING LIGHTING AND CONTROL SYSTEMS SHALL REMAIN OPERATIONAL DURING THE PHASED TRANSITION UNTIL THE NEW SYSTEMS ARE OPERATIONAL.
4. SEE ARCHITECTURAL DEMOLITION PLANS. COORDINATE DEMOLITION WITH THE OWNER'S PROJECT MANAGER AND PROJECT PHASING PLAN BEFORE FIXTURES, DEVICES, OR WIRING IS REMOVED.
5. REMOVE ALL DEMOLISHED MATERIALS FROM THE SITE AND DISPOSE OF PROPERLY AND LEGALLY.
6. FIELD VERIFY EXISTING CONDITIONS AND PROJECT SCOPE PRIOR TO BIDDING THE PROJECT.
7. INCLUDE IN THE SCOPE OF WORK, TEMPORARY SERVICES FOR LIGHTING, EQUIPMENT, AND DEVICES THAT MUST BE TEMPORARILY RELOCATED DUE TO CONSTRUCTION PHASING. SEE THE PHASING PLAN AND COORDINATE WITH OWNER'S PROJECT MANAGER.
8. RELABEL ALL UNUSED CIRCUIT BREAKERS AS SPARES AND TURN THEM OFF.
9. ALL SWITCHBOARDS, TRANSFORMERS, AND PANELBOARDS ARE TO REMAIN.

**KEYNOTES**

1. EXISTING LIGHT FIXTURES IN THIS AREA TO REMAIN "AS IS". MODIFY THE WIRING AS REQUIRED TO MAINTAIN CONTINUITY TO THE REMAINING FIXTURES ON THE SHEET.
2. EXISTING MAIN SWITCHBOARD TO REMAIN. REFER TO SHEET E6.2 FOR MODIFICATIONS.
3. EXISTING PANEL BOARDS TO REMAIN AND BE RE-PURPOSED. REFER RESPECTIVE PANEL SCHEDULES ON SHEET E6.2.1 FOR MODIFICATIONS.
4. DISCONNECT AND REMOVE EXISTING STOREFRONT SIGN BACK TO SOURCE.
