3. TENDON FORCES SHOWN, PROVIDED IN KIPS FOR CONCENTRATED TENDON GROUPS AND IN KIPS PER FOOT FOR UNIFORM TENDONS, ARE EFFECTIVE (AFTER ALL LOSSES).
4. POUR STRIPS TO REMAIN OPEN FOR 90 DAYS AFTER INITIAL CONCRETE POURS. REFER TO '5555' FOR ADDITIONAL REQUIREMENTS.

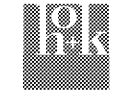

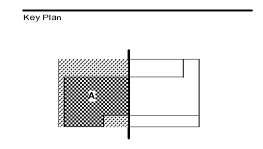
