GENERAL FINISH NOTES

- A. GENERAL NOTES:**
1. TRUE NORTH USED FOR NORTH, EAST, SOUTH, AND WEST DESIGNATIONS. REFER TO NORTH ARROW ON FLOOR PLANS.
 2. ALL WALLS TO BE PT-01, UON.
 3. ALL GWS CEILING TO BE PT-01, UON.
 4. ALL VERTICAL SURFACES UON SHALL RECEIVE WALL BASE COVE BASE AT RESIDENT FLOORING, UON.
 5. REFER TO ENLARGED PLANS, ELEVATIONS AND DETAILS FOR CLARIFICATION OF EXTENT OF FINISH MATERIALS AND ADDITIONAL INFORMATION.
 6. PAINT CEILING ACCESS PANELS WHERE THEY OCCUR TO MATCH ADJACENT CEILING FINISH.
 7. APPLY FABRIC SO WALL IS DIVIDED WITH A MINIMUM NUMBER OF BEAMS, AND WITH EQUAL WIDTH PANELS UON.
 8. ALL INTERSECTIONS OF FLOOR FINISH MATERIALS SHALL BE SET DIRECTLY UNDER CENTER OF DOOR, WHERE OCCUR UON.
 9. PAINT ALL EXPOSED SURFACES, UON INCLUDING DOOR FRAMES, CASES, FIRE HOSE OR EXTINGUISHER CABINETS, CASED PIPING, ETC. UON.
 10. ALL COLUMNS TO RECEIVE GWS AND FINISHING, UON.
 11. ALL DOOR FRAMES TO BE PT-11.
 12. ALL WALLS TO BE PT-01, UON.
 13. ACCEPTABLE WALL FINISHES: FABRIC WRAPPED PANEL, PLASTER, AND TILE SHALL RECEIVE WITH FINISH, UNLESS STES.
 14. REFER TO FINISH AND WPS SCHEDULE ON A 220 AND 220.1 FOR FURTHER WORK.
 15. ALL EXPOSED STRUCTURE CEILING TO BE PAINTED WITH PT-0X, UON.
 16. CORNER GUARDS (CG-1) INSTALL ON ALL EXTERIOR CORNERS WHERE WHEEL CHAIR AND STRETCHER TRAFFIC OCCURS U.N.O. AND CORNER GUARDS SHALL OCCUR IN PUBLIC LOBBY SPACES U.N.O.
 17. TRANSITION OF FLOORING MATERIAL TO OCCUR IN CENTER OF CLOSED DOOR. SCHLUTER STRIP, SCHEME (ALUMINUM FINISH) TO BE USED WHERE DIFFERENT MATERIALS MEET OR INTERSECT U.N.O. MAINTAINING ADA AND TRIP FREE TRANSITION OF FLOORING SURFACES. SIZE AND/OR HEIGHT OF TRANSITION STRIP TO BE DETERMINED BY CONTRACTOR BASED ON SURFACES JOINED.
 18. WALL MATERIALS (IE. TILE, WALL PROTECTION, ACCENT PAINT COLOR, ETC) SHALL NOT END ON AN EXTERIOR CORNER U.N.O. ON PLAN.
 19. DIAGONAL ZINC STRIPS TO OCCUR IN LOBBY. REFER TO PLAN FOR PATTERN.
 20. UNDERSIDE OF EXPOSED CONCRETE PARKING FLOORS SHOULD BE PAINTED WHITE.
 21. EXTERIOR OF THE CONCRETE PARKING VEHICULAR BARRIERS WILL BE PAINTED LIGHT GRAY.
 22. ALL WALLS WITH ACCENT PWC-2 THROUGH PWC-5 TO RECEIVE LEVEL 5 FINISH ON PARTITION TYPE.

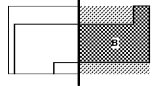
