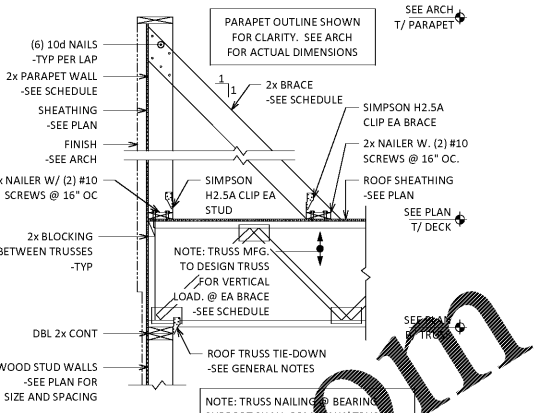

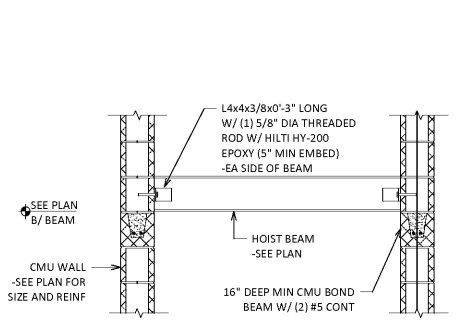
**9** SECTION AT CMU WALL PERP TO ROOF JOISTS AND CORRIDOR FRAMING

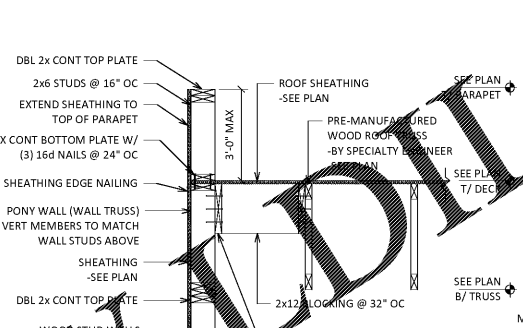
**5** PARAPET SECTION PERP TO ROOF TRUSS

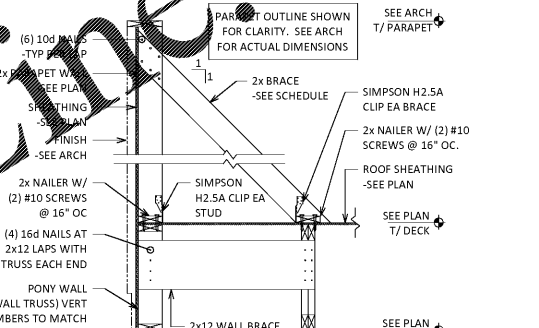
**1** TYPICAL SECTION AT PARAPET PERP TO ROOF TRUSSES

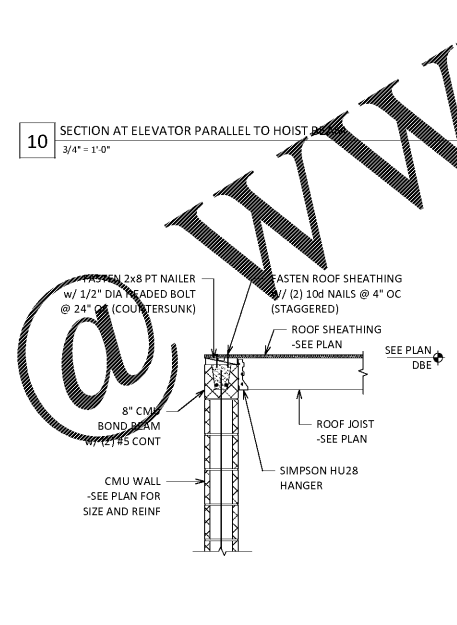
**10** SECTION AT ELEVATOR PARALLEL TO HOIST BEAM

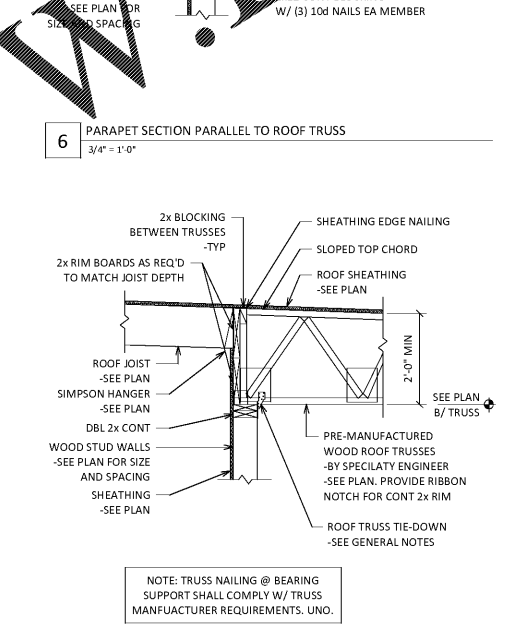

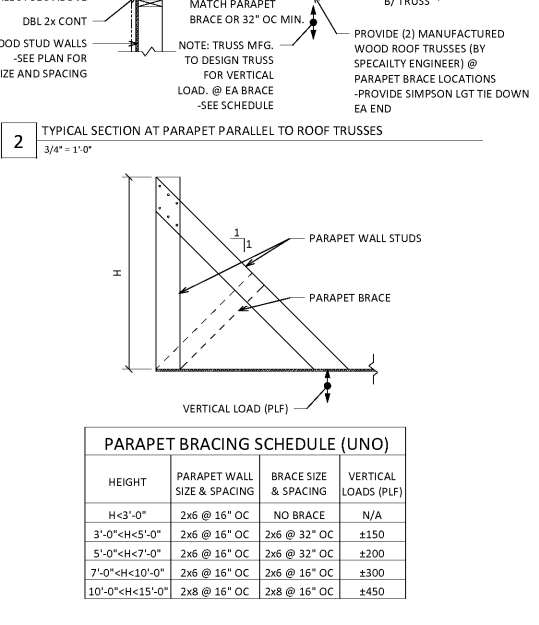

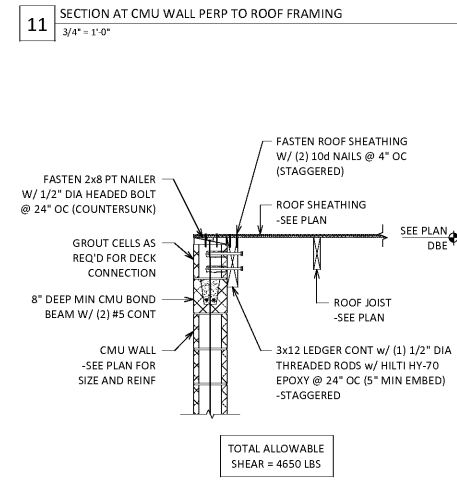

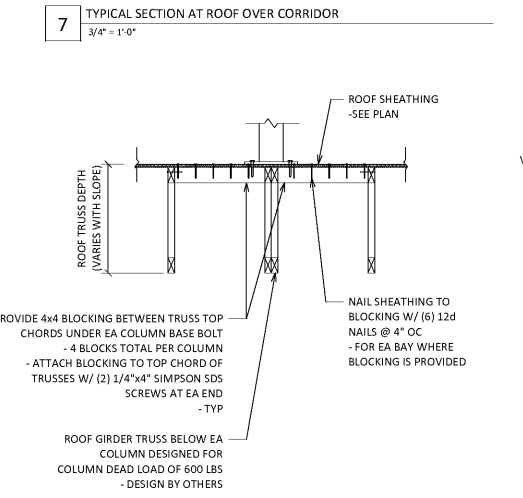

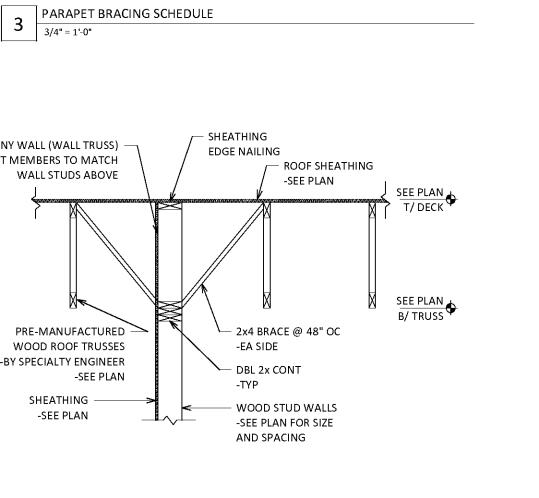

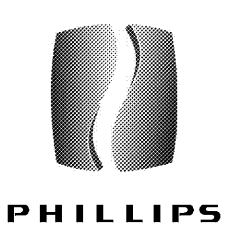
