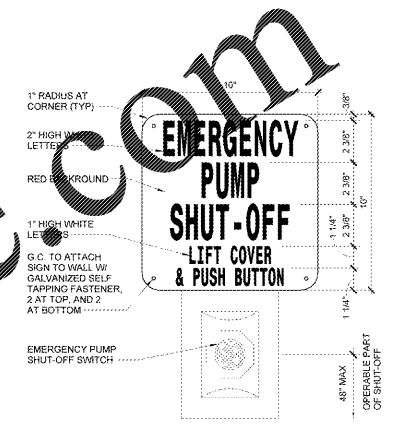

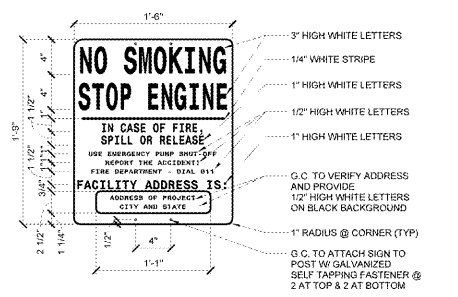

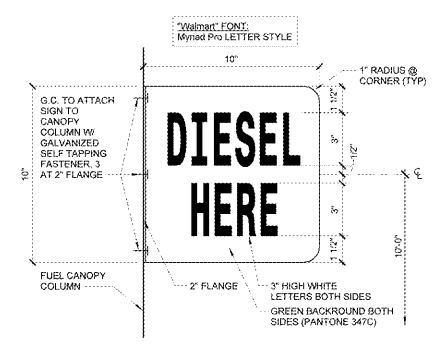
**4 SIGNAGE @ EMERGENCY PUMP SHUT-OFF**

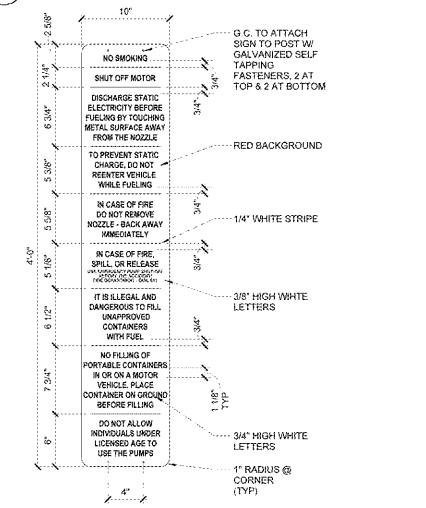
**3 SIGNAGE @ TELEPHONE POST**
