5	2 HOUR FIRE RATED PARTITION @ FIRE WALL, 8" CMU FLUSH TO ROOF DECK, UL DESIGN #9095
6	12" CMU PARTITION, 12" CMU UP TO 2' MIN ABOVE FINISHED CEILING
7	9 1/4" STUD PARTITION, 5/8" GYP BOARD (BOTH SIDES) ON 8" 22 GA METAL STUDS @ 24" O.C. TO 8' MIN ABOVE CEILING WITH SOUND BATT INSULATION. BRACE TO STRUCTURE AT 48" O.C. MAX.
8	4 7/8" STUD PARTITION, 5/8" GYP BOARD (BOTH SIDES) ON 3 5/8" 22 GA METAL STUDS @ 24" O.C. TO 8' MIN ABOVE CEILING WITH 3 1/2" SOUND BATT INSULATION. BRACE TO STRUCTURE AT 48" O.C. MAX.
9A	CMU PARTIAL HEIGHT WALL, 8" CMU (9A), OR 8" CMU (9B) UP TO HEIGHT AS INDICATED ON PLAN OR SECTION, USE INVERTED CMU BOARD BEAM ON TOP COURSE.
9B	8" CMU PARTIAL HEIGHT WALL, 8" CMU UP TO 2' MIN ABOVE FINISHED CEILING
10	SOUND AND SMOKE PARTITION, 8" CMU (10A) OR 12" CMU (10B) FLUSH TO ROOF DECK, SEAL TIGHT TO DECK, FILL ALL VOID CELLS WITH FOAM IN PLACE MASONRY INSULATION, SOUND SEAL ALL PENETRATIONS, UL DESIGN #9095
11A	8" BRICK VENEER, 4" BRICK VENEER UP TO 2' MIN ABOVE FINISHED CEILING

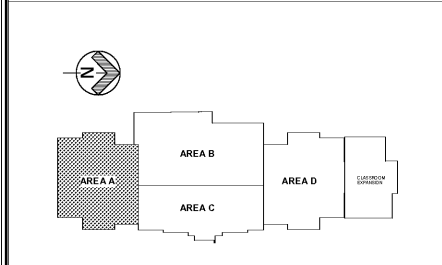
