GENERAL NOTES

The Architectural drawings must be used in conjunction with the Civil Structural, MEP, Fire Protection drawings and specifications. The Contractor is responsible for all coordination between the drawings. Discrepancies should be brought to the attention of the architect.

The Contractor is advised that the available space for routing all electrical, mechanical, plumbing, fire protection and communications piping, conduit, trays and ductwork may be limited in many locations. The Contractor shall coordinate all of the trades work and make adjustments, where the Architect's approval to the routing of these items as required. Any remarks resulting from the routing to coordinate shall be performed by the Contractor at no additional cost.

All dimensions are from face of stud, U.D.O.

All penetrations of fire rated assemblies shall be fire blocked and sealed per UL approved methods.

All concealed fire rated assemblies shall be provided with signage indicating the type of assembly and the fire rating in hours in letters no smaller than 2" high. See 101.2.

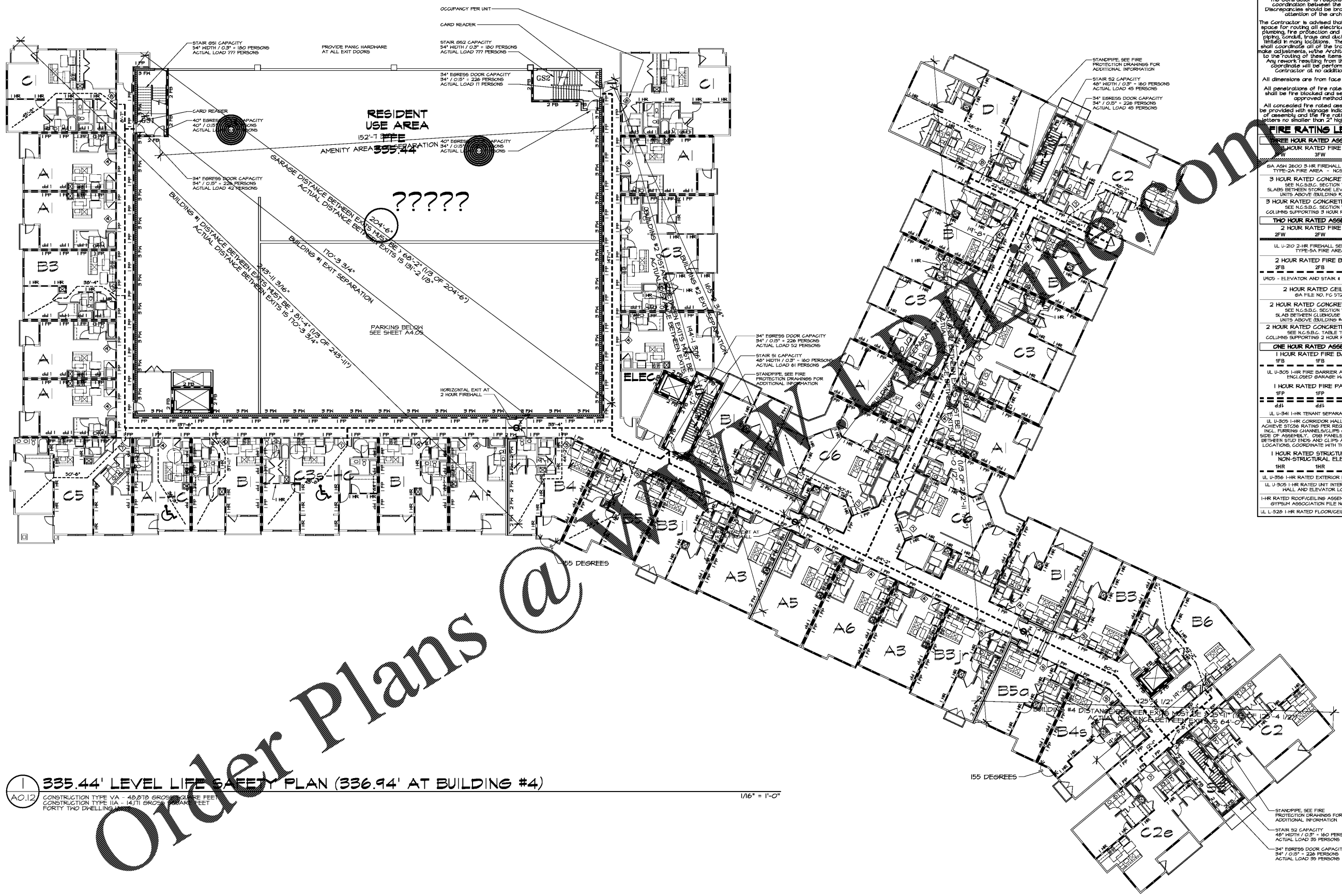
