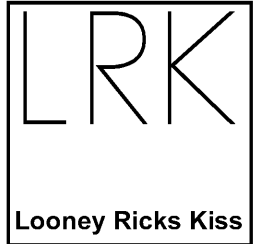


DRAWING NOTES

- A. PLEASE REFER TO SHEET E000 FOR PROJECT NOTES, LEGEND, AND ABBREVIATIONS.
- B. FINAL LOCATION OF CONDENSING UNITS (DISCONNECTS) AND METER BANK VARIES BY UNIT.
- C. FRONT PORCH LIGHTS AND GFCI OUTLETS BY CONDENSING UNITS SHALL BE CONNECTED TO THE HOUSE PANEL. UP TO THREE HOUSE PANELS MAY BE TIED TO EACH HOUSE METER.
- D. PROVIDE WIRELESS DOORBELL FOR EACH UNIT.
- E. SEE SPECIFICATION SECTION 281300 FOR SECURITY SYSTEMS REQUIREMENTS.
- F. REFER TO SITE PLAN SHEET E002 FOR ELECTRICAL METER CENTER LOCATIONS.

KEY NOTES

- 1 PROVIDE 12X12 RECESSED ENCLOSURE FOR CATV, TELEPHONE, SECURITY, ETC. TO DISTRIBUTE TO INDIVIDUAL ROOMS. PROVIDE METER BOX ENCLOSURE EQUAL TO PRIMEX P3000. PROVIDE RECEPTACLE IN BOTTOM OF BOX. RUN UTILITY CABLES FROM ENCLOSURE TO OWNER'S EGRESS OUTSIDE WALL.
- 2 CIRCUIT FOR RADON FAN IN ATTIC. IF ACTIVE, 200W IS REQUIRED. CIRCUIT SHALL BE FED FROM HOUSE PANEL.
