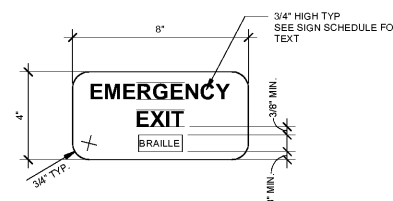
SINGLE LINE TEXT SIGN - (S1) ①

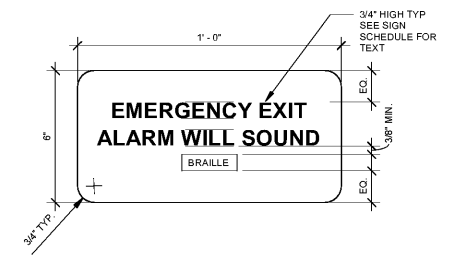
DOUBLE LINE TEXT SIGN - (S2) ②

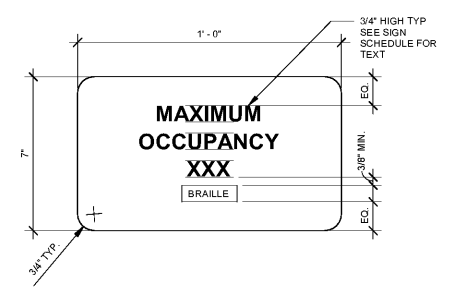
RESTROOM SIGN - (S3) ③

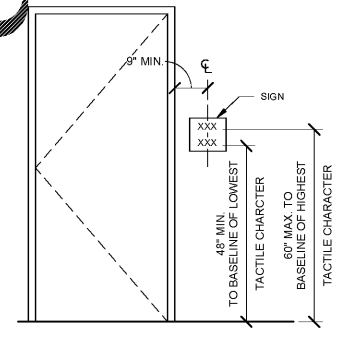
EMERGENCY EXIT SIGN - (S4) ④
