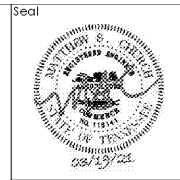

 - 15. ALL SHEAR WALLS SHALL BE BRACED DURING ALL PHASES OF CONSTRUCTION UNLESS OTHERWISE NOTED IN SITE SPECIFIC DRAWINGS.
